B. CSF Funding Opportunities Judy Morgan, External Affairs Chair/Rob Whitten, CEO
i. Core Funding: Calendar Year 2025/2026

The External Affairs Committee met earlier this week to review staff recommendations for the Core Funding: Calendar Years 2025/2026 opportunity. Summaries of partner projects and a proposed funding slate were circulated with the board packet. The fund initially received 108 LOI's totaling about \$147M in funding requests. Today's action will consider 74 projects from 65 different agencies totaling \$38.gM over two years. The proposed slate is attached to these minutes.

A motion was made to approve the Core Funding Calendar Year slate for 2025-2026 not to exceed \$19,150,147 in Year 1 and \$19,709,637 in Year 2.

Following the discussion at last month's board meeting regarding the creation of a new funding category entitled "Cultivation", there are six projects being recommended for funding under this category. These 6 projects are from 6 agencies, and total \$1,7M over 2 years. These projects were initially submitted for Core Funding. This Cultivation funding source will provide specific support for emerging agencies/programs and be an asset-based approach that helps build up agencies. The factors considered are impact. size of agency, organization budget, tenure of organization, and potential for future Core Funding. The proposed slate is attached to these minutes.

A motion was made to approve the Cultivation Funding Calendar Year slate for 2025-2026 nottoexceed \$855,499 in Year 1 and \$874,217 in Year 2.

- V. Strengthening Partners- Judy Morgan, External Affairs Chair/ Rob Whitten CEO
 - A Fall Site Visits

The program team is conducting fall site visits now until November. The goal is to identify any barriers and strengthen partnerships. These visits involve meetings with Core and Collaboration partners. With the upcoming implementation of the Fluxx system, site visit information will bedocumented through a new form in the Fluxx portal. The board expressed interest in seeing partners' work firsthand. In response, the program team proposed arranging a day with 2-5 site visits, allowing board

 - A Children's Services Community Assessment

Dr. Mosley advised the assessment is progressing, with all focus groups for this stage completed. Next steps include conducting surveys with agencies and parents/caregivers. A virtual reflection session is scheduled for October 30th allowing stakeholders to review initial findings, provide feedback, and identify any gaps before final data collection. This session will help ensure the assessment fully captures relevant insights as it moves toward completion.

VII. Optimize Organization- Amy Harris, Internal Affairs Chair/Rob Whitten, CEO A Organizational Updates

> 1. Grant management software- Celeste Ortiz, Contract Administrator The Fluxx grant management software, in development since April. will manage applications, billing, and reporting. Three of four data migrations are complete, with the final migration expected by the end of October. Applications, reports, and reviews have been built and are in testing. while the partner budget component is still under development. The team aims for a December 1 go-live date, but may adjust if further testing is needed to ensure a smooth transition.

2. HR Engagement

Mr. Whitten provided an update on the engagement with OMNI for HR services. While some deliverables were delayed or lost in transition with former OMNI representative, the company will continue finalizing key documents and verifying personnel files for consistency.

3. Conflict of Interest Disclosure

Mr. Whitten advised board members they are receiving the 2024 conflict of interest declaration forms today. Members are asked to review and disclose any potential conflicts with partnering agencies.
